NOTIFICATION

The 12th March, 2018

No. HLB 650/2017/167. - The Governor of Assam hereby makes the following Regulations to further amend the Medical and Health Recruitment Board Regulations, 2017, hereinafter called the principal Regulations, in the manner hereinafter appearing, namely: -

1. Short title and commencement. -

- (1) These regulations may be called the Medical and Health Recruitment Board (Amendment) Regulations, 2018.
- (2) They shall be deemed to have come into force on and from the 6th day of January, 2018.

2. Insertion of regulations 17A and 17B:-

In the principal Regulations, after regulation 17, the following new regulations 17A and 17B shall be inserted, namely:-

"17A.(i) It shall not be necessary for the Board to be consulted in matters relating to methods of recruitment to posts mentioned in Schedule - I to these Regulations or the suitability of the candidates for such appointments, when an ad-hoc temporary appointment is to be made by direct recruitment to any of the aforesaid posts, if it is necessary in the public interest that the appointment should be made immediately and reference to the Board would cause delay; provided that if the vacancy is for a period, actual or probable of four months or more, the Board shall, as soon as possible, be consulted for making regular appointments to such posts.

(ii) In the event that regular appointments could not be made to the posts against which ad-hoc temporary appointments have been made under regulation 17A(i) before the expiry of the ad-hoc temporary appointment tenure of four months, the tenure of such ad-hoc temporary appointment may be extended not exceeding four months at a time.

17B. Notwithstanding anything contained in regulation 17A(ii), the officials who were appointed to the posts in Schedule - I to these regulations, under regulation 3(f) of the Assam Public Service Commission (Limitation of Functions) Regulations, 1951 prior to coming into force of the Medical and Health Recruitment Board (Amendment) Regulations, 2018 shall be deemed to have been appointed under regulation 17A and their tenure of services can be extended under these regulations for such period as may be required, including the period prior to coming into force of these regulations."
