NOTIFICATION

No.MER.354019/283.-In revocation of this Department's Notification No. MER.354019/260 dated 19/12/2023 and in view of commencement of Mukhya Mantri Lok Sevak Arogya Yojana (MMLSAY) for Medical Reimbursement of Government employees, Government pensioners and their dependents through an online IT portal; the Governor of Assam is pleased to notify the following rates of monthly subscription and process thereof for deduction of the subscription in case of Government employees and pensioners.

- i. Monthly subscription contribution will be according to the grade in which the employee is currently employed at the time of registration. The monthly subscription contribution will be as follows :

Grade of the employee	Subscription per Month(Rs.)
IV	125
III	225
II	325
I	500

- ii. The subscription rate for the pensioners will be annually or one time life time subscription, which will be 10 times of the annual subscription (10 years contribution).
- iii. In case of pensioners, the grade at the time of retirement will be considered for rate of annual or one-time life time subscription (10 years contribution).

- iv. Fin Assam will make provision to deduct the subscription monthly during the salary bill preparation by DDOs as per the grade of the employees.
- v. Drawing and Disbursing Officers of the employees will deduct subscription towards MMLSAY as per the Grade and the corresponding rate of subscription as per the table given above.
- vi. Deduction will be made against employee by transfer under the receipt head 0210-01-800 from the month of December 2023.
- vii. In case of those Government employees who are not willing to be included in MMLSAY and want to opt out, the concerned DDO may raise a ticket (TSG) within Fin Assam with supporting documents so as to remove the option for deduction of that particular employee from subsequent salary month. This needs to be supported by the request for the same from the employee.
- viii. Pensioners will have to pay the contribution amount during the time of registration as per their corresponding grade at the time of retirement through e-GRAS(Government Receipt Accounting System) credited to the receipt head 0210-01-800.
